

#### Welcome

Please please please use voxer any time you need to reach me with ideas, problems, questions, etc., or to have a quick alignment call.

### Challenges

If I ever say or do anything that upsets you or doesn't feel right, please bring it to my attention so that we can resolve it as soon as possible. My objective is to have an aligned coaching relationship that is fully open, honest, real and trusting in our communication styles. We should both realize that communication via telephone, voxer or email entails extra challenges since we can not see body language, facial expressions, etc. Therefore, we need to give each other plenty of latitude, and promptly ask for clarification if there is a mis-connection.

## Frequency of the Sessions

At the start you will have an intake alignment call. Then you will have 2 one (1) hour alignment calls per month during your 3-month commitment.
